Article 371 of the Colombian Constitution establishes that *Banco de la República* (the Central Bank of Colombia) performs central banking functions and is organized as a legal entity of public law with administrative, financial, and technical autonomy, subject to its own legal framework. Likewise, according to Article 40 of Law 489 of 1998, *Banco de la República* is identified as a state entity or agency subject to a special regime granted by the Colombian Constitution and to the provisions established by the respective laws.

Accordingly, since *Banco de la República* is the only central banking entity with its own legal framework and administrative, financial, and technical autonomy, **there are no other entities that make up the central banking sector.**
